1. There shall be average 31 periods of class per week for 3<sup>rd</sup> & 5<sup>th</sup> semester, 33 periods of class per week for 4<sup>th</sup> semester and 27 periods of class per week for 6<sup>th</sup> semester. Each period is of one hour.
2. The remaining periods out of 7 periods per day on every working day will be utilized for imparting add on courses for enhancing Communication Skill, Digital Skill and Technical Skill of the students.
3. Principals are to arrange extra classes, during Holidays and off hours, wherever necessary, to complete the syllabus in time.
4. The Internship for students must be arranged at Institution level.
5. Attendance Registers must be maintained in the prescribed cumulative manner by faculties in every class.
6. At least two monthly tests per semester are to be conducted apart from Internal Assessment.
